We have done our best to come up with a generic schedule that is based on heights. There will be a separate show offered each day for three days of each week. Please note that only one office fee will be charged per week. The option is yours to show in whatever classes you want each day. Different courses will be set for each competition day as well as a rotation of hunter judges. We plan on using posted orders and signups that can be selected through the SGL online system. Please note that the maximum amount of trips allowed in each ring are listed per day. If you cannot be accommodated on one day we will give priority to you for the following day.

Management reserves the right to modify this schedule at any time that is necessary to accommodate safety and welfare and entries that may be on a waiting list. This includes but not limited to ring changes to any ring at PBIEC, canceling warm up classes and combining divisions.

Courses with distances will be posted online each day. Please go to [pbiec.coth](#). Click the "Competitors" drop down menu at the top of the screen and select the Ring and Date where you will be participating. We will post courses at the ingate but you are asked to be familiar with your courses before coming to the ring. Please note, there will be no walks allowed once the show begins. All courses can be walked from 7:00 am- 7:45 am each morning with riders keeping strict social distancing protocols with a minimum of 6 feet of separation. NO EXCEPTIONS!

We ask that exhibitors rely on your trainers and their staff to give the best times for when you will show. Riders and parents will not be allowed in the barn areas. We ask that you remain in your cars until it is your turn to mount, warm up and be ready to compete in the ring on time. Please keep in mind that we will be enforcing time limits on when you are expected in the ring. Be considerate to your fellow competitors showing after you that are monitoring their posted times. ESP ingate personnel will be updating the SGL system to the best of their ability however, keep in mind there are unforeseen situations that can cause delays. (Injuries, thrown shoes, thunderstorms, etc.) Again, please be prepared to get the most accurate information from your trainers or staff before going to the ring.

One important note about Thunderstorms. PLEASE plan on going to your cars in the event of any delay. We cannot afford a situation where groups of people try to go to a single area violating the social distancing protocols. Your personal car should be your safe place at all times.

We ask for your patience while we all navigate these challenges due to the COVID-19 environment. Any new showing protocols are being instituted for everyone's safety. These changes are challenging to all of us and we appreciate your understanding in advance.

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of ESP as published in the ESP June Prize List and on the website at pbiec.coth.com, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any ESP Event involves risks and dangers including, with- out limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the ESP Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("**Risks**").

EQUINE ACTIVITY LIABILITY ACT WARNING:

C. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any ESP Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any ESP Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: Equestrian Sport Productions, LLC, Wellington Equestrian Partners, LLC, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any ESP Event; any charity or other beneficiary which may benefit from the ESP Event; the owners, managers, or lessors of any facilities or premises where a ESP Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the ESP Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.
