GENERAL STABLING RULES

1. For safety, all persons accessing the show grounds in 2022-2023 must meet the current COVID-19 CDC requirements before access is granted. All horses are subject to WEF 2023 Wellington International biosecurity protocols before stabling or showing at the facility. Everyone will be required to sign a waiver and acknowledge these protocols before being allowed on the property. No exceptions.

2. No horse transport vehicles of any kind will be allowed on the property Wednesday – Sunday between the hours of 6:30 am and 8:30am.

3. NO PAINTING STALLS OR ATTACHING ANY OBJECTS OUTSIDE OF STALLS WITHOUT OBTAINING PRIOR WRITTEN PERMISSION FROM MANAGEMENT. CHARGES FOR REPLACING PAINTED WOOD, DAMAGES, OR REMOVING ATTACHMENT WILL BE APPLIED.
