Important CDI Class Information:

Horse inspection on Wednesday February 22 at 2:00 pm

Grand Prix (CDI3*): Class 500 Grand Prix qualifies for Class 501 Grand Prix Freestyle and Class 502 Grand Prix Special (must receive at least a 60% in the GP). Must declare either Grand Prix Freestyle or Grand Prix Special at the time of entry. No Changes after definite date. Limited to 2 horses per rider for the Grand Prix. Class 501 Grand Prix Freestyle "FEI Degree of Difficulty" – Floorplan will be used.

Medium Tour (CDI2*): Intermediate A & Intermediate II. Limited to 1 horse per rider.

Small Tour (CDI1*): Prix St Georges, Intermediate I, Intermediate 1 Freestyle (not compulsory). Limited to 2 horses per rider.

FEI Junior Rider / FEI Young Rider / FEI Pony Rider: Team, Individual & Freestyle (compulsory). JR/YR limited to 2 horses per rider, Pony limited to 1.

FEI Children Rider: All Children entries must ride Team Test to qualify for the Individual Test. Limited to 1 horse per entry.

FEI Amateur Classes: Athletes from 26 years. Athletes must have no ranking on the FEI Dressage World Ranking List at the date of definite entry. Athletes living abroad may compete in Events of their host country, with permission from the NF of their host country. FEI Passport not required if competing in their home country, however these horses must have a National Passport and be registered with their NF, be identifiable by diagram, and have a valid vaccination certificate. Limited to 1 horse per rider.

FEI Young Horse Classes: Limited to 1 horse per rider and must have a valid passport.

CDI Awards Information:

Prize Money and Tax Information: Prize money for competition will be paid directly by the facility accounting office to the designated payee within thirty (30) days of the end of the competition. U.S. Athletes must report winnings to IRS Form W9. Prize Money Won by Foreign Competitors: Be advised that the U.S. Internal Revenue Service requires sporting events to withhold 30% of prize money won in the United States. Foreign competitors should apply for a U.S. Social Security number and will be asked to complete form 8283 or complete a W-8 Certificate of Foreign Status form. No prize money will be awarded without proper tax information on file with the show office for each competition. Failure to file proper documentation within one (1) week of the competition with the show office could result in forfeiture of prize money payment.

Young Horse (Prix St Georges)" – Total Prize Money \$10,000 We will offer 5 weeks of qualifying chances at the GDF3, GDF5, GDF7, GDF8 and GDF10 shows with the final being held during the GDF11 show in the International Arena. All horse (7-9 yr old) /rider combinations will need to ride in National Class 368 FEI Prix St Georges on Sunday in International Arena. The best 2 of each week are qualified for the Final. If an already qualified horsed/rider combination is among the 2 best in following weeks again then the next best placed of that week will go forward to the final. A rider can qualify more than one horse for the final. The 10 bests from all the weeks will compete in the final during the GDF11 show.

THE FINAL / GDF11: Each qualified rider will ride 2 tests of the FEI Prix St Georges, the first will be a warmup and the second will be the Final. Both classes will be ridden in the International Arena. The warmup class will take place on Thursday or Friday and the Final will take place on Saturday.

"Lovsta Stuteri Future Challenge / Young Horse (Grand Prix) – Total Prize Money \$15,000

We will offer 5 weeks of qualifying chances at the GDF3, GDF5, GDF7, GDF8, and GDF10 shows with the final being held during the GDF11 show in the International Arena. All horse (8-10yr old) /rider combinations will need to ride in the National Class 369 FEI Intermediate II on Sunday in the International Arena. The best 2 of each week are qualified for the Final. If an already qualified horse/rider combination is among the 2 best in following weeks again then the next best placed of that week will go forward to the final. A rider can qualify more than one horse for the final. The 10 bests from all the weeks will compete in the final during the GDF11 show.

The FINAL / GDDF11: Each qualified rider will ride 2 tests, the first will be a warmup (Int 2) and the second will be the Final (YH GP). Both classes will be ridden in the International Arena. The warmup class will take place on Thursday or Friday and the Final will take place on Saturday.

Format

Combined teams of Small and Big Tour horses, 1 Big Tour combination mandatory, which means:

4 Combinations:

- a) 3 Small Tour / 1 Big Tour
- b) 2 Small Tour / 2 Big Tour
- c) 1 Small Tour / 3 Big Tour
- d) 4 Big Tour

3 Combinations:

- a) 2 Small Tour / 1 Big Tour
- b) 1 Small Tour / 2 Big Tour
- c) 3 Big Tour

Individuals may compete in Small or Big Tour

In the case that there are not enough teams with at least one Grand Prix horse (total of max. 40 combinations) the OC may accept also teams with Small Tour horses only.

Tests

Small Tour: Prix St. Georges / Intermediaire 1 / Intermediaire 1 Freestyle Big Tour: Grand Prix de Dressage / Grand Prix Special / Grand Prix Freestyle

1. Day / Team Competition (PSG/GP):

2. Day / Final Team Competition (I1/GPS) all, except those under 60% in GP

3. Day / Individual Final Competition (I1F / GPF) max. 15 best out of I1 and max. 15 best out of GPS except those under 60% in GPS

All tests from Small and Big Tour (PSG/GP - Intermediaire 1/GPS - Intermediaire 1 Freestyle/GPF) will held on the same day)

Draw

Will be conducted as one draw in two parts, one for the Small Tour and one for the Big Tour. Chef d'Equipes will determine the starting order of team members within the team according to the existing

rules. PSG/GP

Draw according to Art.456.1. The Small Tour Riders are first to go in the Team Competition. The Chef d'Quipe will determine the starting order of team members within the team. The team rotation will be kept through both parts of the test (PSG/GP)

I1/GPS

Draw according to Art. 456.2. The Small Tour Riders are first to go in the Team Competition. The starting order of the riders within the team will remain the same as in the PSG/GP. All team and individual riders are qualified for the I1 and the GPS, except those under 60% in the GP.

I1FS/GPFS

15 Best from the I1 qualified for the I1FS and the 15 best from the GPS for the GPFS, except those under 60% in GPS. There is a separate classification for I1FS and GPFS. Draw according to Art.456.3 in groups of 5.

Team Scores

There will be a bonus of 1.5% for each GP/GPS rider per team. The team riders of Small Tour remain without bonus. The drop score will be determined after adding the bonus to the GP/GPS results. Of one of the GP riders are the drop score of the team, the bonus will be also dropped.

The team results consist of the 3 best scorers of the first test (PSG/GP) and the 3 best scores of the second test (I1/GPS).

The team with the best total team result will get Gold, the second best Silver and the third best Bronze. Bonus points are only used to find the team rankings and will not count for the qualification for the Individual Final Competition.

Individual Scores

The Individual riders in the Big Tour will not get bonus points. The bonus points for the GP/GPS will not count for the Dressage World Ranking List, but the GP/GPS/GPFS results may count.

CDIO U25

Please refer to the FEI Rules Annex 6, directly to the I2 Team Competition and GPU25/GPFS Individual Competition. Each NF may send a team with up to 3

Athletes. Per team a maximum of 3 athletes may participate in Team Competition (the results of the 2 best athletes count towards the team classification). Individual entries accepted.

<u>CDI NO SHOWS / WITHDRAWALS:</u> Amount charged: Total amount of Entry fees (in full) if the entry is still in the FEI system the day after definite entry. It is the sole responsibility of the rider to inform the National Federation of a withdrawal to ensure that the entry is out and removed from the FEI Entry System by the date of definite entry. Failure to do so will result in entry fees being charge

Important National Class Information:

Amateur Classes (AA) O Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.

- Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in
 possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost).
- o Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules. o If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF.

The Junior/Young Rider Classes (JR/YR)

Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21

The Pony division

For this competition, classes are offered from USEF Training Level through USEF Third level with classes designated for the JR/YR, the Adult Amateur, and the Open riders. The pony division is open to all breeds that meet the following measurement requirements. In the Dressage Division, a pony is an animal that does not exceed 148 cm (14.23 hh) without shoes, and 149 cm (14.27 hh) with shoes. The pony can be of any sex (Mare, Stallion, or Gelding).

- Ponies under the age of eight and in possession of a valid temporary card from another division or discipline should submit a copy with their entry.
- Measurement will be required for these pony specific classes if they do not currently have a valid measurement card. Measurement will be yearly beginning from the age of three (36 months) until the pony has reached the age of eight years. Animals three through seven years old will be issued an annual Temporary Certificate of Measurement and must be re measured annually until the age of eight years. Animals eight years and older will be issued Standard Certificates of Measurement which will not need to be renewed. Measurement must be done on USEF Combined Driving and Dressage Pony Measurement form. Individual responsible for presenting the pony for measurement must be 18 years old. Animals submitted for measurement or re-measurement must show no evidence of lameness and must be jogged for soundness prior to the measurement. Animals showing evidence of lameness are not eligible for measurement or re measurement.
- The pony must be entered to compete at the competition for a measurement to take place.
- When the competition veterinarian is on call and an alternative measurement time is necessary, management must receive a
 written request for measurement from the owner or agent at least five days prior to the start of competition to set up a time.
- o It will be the pony owner's responsibility for the fee charged (if any) by the veterinarian. This must be done prior to first ride.

Classes per Day

Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below (including Rider Tests) or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

Consecutive Levels

Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

Arena Size

All classes will be conducted in a standard size arena (20 m x 60 m)

Current Rules: The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on www.usef.org.

Awards for National Classes: Ribbons to sixth place for each class. Divisions (JR/YR, AA, Open) may be run concurrently as one class. Divisions will be pinned separately. Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as open. Riders may enter only one division per class.

Any additional prizes will be posted at the show office.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

Entry Information:

Entry Information Requirements: Competitors are responsible to provide valid membership numbers on the entry form for all horse, owner, rider, and trainer names listed on the entry form. USEF and USDF registration is verified electronically if valid membership numbers are provided on the entry form. You may be asked to provide copies of your membership documents if your memberships cannot be verified for any reason. All hard copy entries must include copies of all memberships for horse, owner, rider and trainer listed on entry form. NO ENTRIES WILL BE ACCEPTED WITHOUT MEMBERSHIP CARD COPIES & COGGINS. No horse will be permitted on the grounds without a valid health certificate or proof of vaccinations (Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) with 6 months prior to arriving. Rule GR845

Entries must be received by Midnight of the closing date in the time zone of the competition. Any entry requiring a signature, payment, or copies of proof of valid membership will be considered incomplete and may incur additional fees. No refunds after closing date, for any reason.

- All fees must be paid in US funds. Fees must accompany the entry form for each show entered. Entries not accompanied by fees will be considered late and not entered until fees are received including any late or post entry fees.
- Entries postmarked or submitted after closing date will be considered late. Numbers will not be given out until entries have been submitted to the show AND owners, riders and coaches or trainers have signed all entry blanks.

All entries for Open Classes are taken on a first come, first served basis. Only one horse-rider combination per entry form

Late Entries: Late entries will be accepted after the closing date if space is available, upon payment of an additional late entry fee.

Post Entries for: Entries will be accepted to fill scratches, up to the start of competition, if scheduling permits. No late entry fee will be required but will be required to pay a post entry fee in addition to the normal class fee.

Policy for Accepting Post Entries and Filling Scratches in classes: Must be eligible for class. Must have previously entered in competition as a competing or non-competing horse. Must register with secretary and put name on wait list.

Post entries in national classes will only be accepted to fill scratches in allotted time slots that are available ("allotted time" slots are determined by the Official schedule posted at the show office). Exceptions will be made when two or more competitors meet the same criteria and are deemed equal in priority status. Exceptions may also be made when conditions are created by weather or other natural disasters.

Para-Equestrian competitors and their horses are no longer exempt from USDF memberships. Para-Equestrian competitors will now be required to have a USDF participating membership or a USDF group membership or a Non-Member fee will apply. All horses will need a life or HID USDF membership.

<u>Trailer parking:</u> Please be advised there is no overnight trailer parking at the Global Dressage Festival show grounds during shows. All trailers must be removed from the facility after unloading. These trailers must be taken home or taken to our offsite trailer parking lot. (Maps are available in show office) To park in the offsite trailer parking lot it will be \$75 per show or \$350 for the show season (pay on entry or at check in) a sticker will be issued to place on your trailer to allow admittance to the lot.

Musical Freestyles: Music must be on good quality CD and must be presented to the announcer at least two hours before scheduled ride. The schedule for sound checks will be posted at the show. All Freestyle entries Training – Fourth Level must submit proof of at least a 63% at the highest class of the level and FEI Levels at least a 60%.

Numbers must be worn at all times when a horse is outside of the stall.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

Weather/Acts of God/Accidents or Emergency Policy: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergencies. Every effort will be made to reschedule with priority given to CDI or USEF Program classes. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.

No Shows: All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

Membership/Registration Requirements:

Riders/Owners/Trainers/Coaches must be current USEF members or a \$45 Non-Member Show Pass fee will apply (See below for Show Pass requirements). Riders/Owners must also be a member of the USDF (participating for GAIG/USDF qualifying) or a \$35 Non-Member fee will apply. Horses must have at least a USDF HID number (\$35) to show. For GAIG/USDF qualifying the horse needs a USEF life or annual membership and a USDF life membership. Horses with only an HID are not eligible.

Show Pass Fee: Effective 12-1-2022 any rider, handler, driver or owner are limited to one Show Pass purchase annually (December 1 November 31). USEF Show Pass will be available for purchase by exhibitors on-line "ONLY". Competitions should not accept payment for show pass fees and therefore this fee should not appear on the entry blank. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF-licensed competition.

Great American Insurance Group (GAIG)/USDF Qualifying Classes: Please indicate that the class is to count for qualifying by placing a Q after the class number on your entry. Qualifying does not require a separate ride. An exhibitor riding in the Open, AA or J/Y rider classes must pay an additional \$15 USDF fee to have this score entered in the GAIG/USDF qualifying division at that level.

Show Schedule and Ride Time Conflicts: It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule. Organizers cannot guarantee that **CDI** draw times will not conflict with open class times.

Show Conflict/Rider Time Conflicts: Changes need to be requested in the show office by 3pm the day prior.

SAFE SPORT STATEMENT: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Horse Health Requirements for Entry: It is recommended that all horses stabling on the AGDF grounds arrive between 8:00 am and 5:00 pm. If it is necessary to arrive at any other time, you must make arrangements with the show office prior to arrival.

Management strives to provide an excellent showing environment. An integral part of an excellent showing environment includes healthy horses. Exhibitors, especially those traveling long distances, can contribute to that healthy environment by following some basic recommendations listed below. Please monitor our web site for any additional and possibly mandatory requirements.

IMPORTANT EQUINE HEALTH INFORMATION

Equestrian Sport Productions has had vaccination protocol in place since 2013. We will now adhere to GR845 in which:

At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.

- In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.
- 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine ministration.
- 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds.
 The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.
- 5. A current negative coggins test. Please renew before it expires, and not just before it is necessary to leave the state. It is strongly recommended that all horses be vaccinated for Equine EHV-1 (either modified live or killed vaccine) no sooner than 7 days prior and no later than 180 days prior to entering the show grounds. Most EHV-1 vaccines are only considered effective for 180 days. Check with your veterinarian about which vaccine you use.
- 6. Once the horse leaves the facility you <u>may</u> be required to show a new Statement Of Health upon your return to the facility. Current vaccination against WNV, EEE, WEE, Tetanus and Rabies is strongly recommended
- 7. You should be able to document your horses normal temperature before arrival. Please do not ship horses with elevated temperatures. It is recommended that you establish a log of temperatures taken at least twice daily. If there is an elevated temperature for more than a 24 hour period, please consult your local Veterinarian immediately.
- 8. Every effort should be made to minimize stress and commingling of horses shipped long distances. Extra hours on a horse van, or moving from stable to stable is the fastest way to compromise your horses' and your neighbors horses' health.
- Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to ESP Management. It is always better to err on the side safety. Isolation stalls will either be available on the grounds or at a local veterinary practice if the need arises.
- 10. Please take the time to review equine good hygiene practices and impress its importance to your groom in everyday care.

- A Preliminary schooling schedule will be posted at the show office. Please check for any updates.
- Lunging hours may be limited, please check posting at the show office.
- CDI warm-up will be open 1 hour prior to first scheduled ride. CDI competition arena will open 1 hour prior to first scheduled ride and will close 15 minutes prior to first scheduled ride.

Footing/Arenas: All competition arenas and designated competition warm-up rings will be standard size with silica sand and fiber manufactured by ESI (Equestrian Services International). Covered competition arena in addition to outdoor competition arenas will be used. Lungeing areas with same footing will be available with restricted hours.

Lungeing areas are available with restricted hours.

Stabling: Temporary stalls are 10'x10' in tent barns and have full doors. Permanent stalls are 12'x12' with full doors in permanent barns. No temporary equipment may be permanently attached to any existing property such as signs, barricades, stabling, trees, etc. Staples, nails, and/or screws of any kind are not allowed.

Bedding: No bedding will be supplied. Shavings are available for purchase at \$12 per bag and order can be included with entry. Exhibitors may also bring their own bedding, but only wood shavings are permitted.

Feed and Hay: Feed and hay can be pre-ordered from Gold Coast Feed and Supply at 561-793-4607. Exhibitors should contact Gold Coast Fees and Supply at least 24 hours prior to their arrival. Exhibitors may also bring their own feed and hay.

Concessions: Food and concessions will be available on the show grounds during competition hours.

Early Arrivals and Layovers: Horses occupying early ship-in or layover stabling allowed provided stabling is available. Schooling areas may be limited. The listed daily fee will be enforced for both horse stalls and tack stalls. Waiver of liability must be on file with the show office for non-competition days.

Golf Cars/Mopeds Etc.: Must be at least 16 year of age, with valid driver's license to operate a golf cart, moped, etc. Golf carts can be rented through Dever (859-233-9702, 859-402-7356 (Tony) or info@deverinc.com, or www.deverinc.com).

In accordance with GR1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Warning: Under the Equine Activity Liability Act, each participant who participates in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

Exhibitors should exercise extreme caution before medicating their horses and should be aware of the US EQUESTRIAN FEDERATION rules governing drugs and medications. Any questions about the use of certain medications and regarding Rule IV should be directed to the USEFFederation Equine Drugs and Medications Program, 956 King Avenue, Columbus, Ohio 43212-2655. (800) 633-2472, (614) 299-7707, FAX (614) 299-7706.

A trainer is defined as any adult who has responsibility for the horse on the competition grounds and must sign the entry form.

Protective Headgear Rule: From the time horses are officially admitted to the competition grounds by competition management, anyonemounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must be immediately prohibited from further riding until such headgear is properly in place. Protectiveheadgear is defined riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

Important notice to all affected parties: Third parties may come upon the property or enter the facilities where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose otherthan granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings.

No Shows: All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots maybe filled. Exhibitors enter with this understanding and agreement.

Sharps Disposal: Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers are located at the end of each barn aisle and within center aisles when center aisles are present within the barns.

Dogs: Facility rules require that dogs must be on a leash (not to exceed 6 feet in length) or suitably restrained in a tack stall/cage etc. Loose animals/animals left in vehicles in distress, etc. can and will be removed from the grounds at the owner's expense.

Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

2023 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2023 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF.
 For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- * PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions:

Owners and riders, including foreign riders

and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
 sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
 Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
 exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
 academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
 identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top three riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

or

Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
- E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.
